Middle and high school attendance area adjustments were approved at the Board of Education meeting on November 17, 2022. A transition process to inform and prepare students and their families for the change is underway. This transition process is being led by School Management and Instructional Leadership (SMIL) and the Office of Program Innovation and Student Well-Being. The School Locator shows geographic school assignments. Students may attend a school other than the assigned school for various reasons, including exemptions to boundary changes (redistricting). Internal student information systems have also been updated with School Year 2023-2024 assignments. Parents/guardians can view their child's school assignments for next year at HCPSS Connect, which includes the parents/guardians' selected exemption.

- The west side of MD-108 (Old Annapolis Road) from Bendix Road to approximately 500 feet north of Red Branch Road, and all streets with egress to that section of MD-108 (Old Annapolis Road)

# **EXEMPTIONS**

#### 9/21/22

Exempt all rising 11th graders with opt-in transportation.

Move only rising 9th and 10th graders to High School #13.

#### 11/14/22

Exempt rising 10th graders at all high schools except HS 13 for the remainder of their high school career with opt in transportation and the parents must apply for reassignment through Policy 9000.

Exempt students who have an IEP or 504 plan or any student who has an IEP or 504 in place as of November 17, 2022. Any student that elects to remain at their sending school will have attendance at that school for the remainder of their term in high school.

Exempt students with one or more parents that are active-duty military personnel with opt in transportation and apply to the Assignment Office through Policy 9000.

Exempt students with one or more parents that are active-duty military personnel as of November 17, 2022, with opt in in transportation and apply to the Assignment Office through Policy 9000.

### 11/17/22

Provide an exemption to younger siblings of students who utilize a grade level exemption to attend their school year 2022-23 assigned school. The younger sibling must share at least one year at the same school as the older sibling.
